#### **5. REQUEST TO CONSIDER ADDITIONAL FUNDS FOR NEVADA STATE RIALROAD MUSUEM GATEWAY IMPROVEMENT PROJECT (For Possible Action)**

For the least several years the Nevada State Railroad Museum has been working toward making landscape and sign improvements at the museum entry off South Carson Street at Fairview Drive. \$55,000 of federal funds is available. The Division of State Public Works is managing the project (16-A038) and the low bid on the work was \$79,300 by Central Sierra Construction. Total project cost is estimated at \$100,532. Considering the high priority of the museum to complete this work the Finance Committee is asked to authorize transfer of \$36,042 from the museum's invested funds at Morgan Stanley to allow this project to go forward. The museum has approximately \$206,000 in available invested funds.

#### **6. REQUEST FOR CATEGORY 48 AUHORITY, B/A 5037 (For Possible Action)**

Request by the Nevada State Railroad Museum, Carson City to access \$8,500 in category 48 authority to complete modifications to the 1926 Edwards Motor Car. This car has suffered considerable maintenance issues and operating failures. These funds would enable modifications aimed at improving reliability and performance. Not having the car available, limits train service during the operating season.
